



LIMITED 5 YEAR WARRANTY

OUTDOOR KITCHENS

Stoll Industries hereby warrants this product to be free from defects in materials and/or workmanship, for the period of time and under the conditions described in each section below, subject to the limitations listed below (see section 2).

1. Limited Warranties

a. Stoll Industries warrants the structure and metal/aluminum materials to be free from defects in materials and/or workmanship for a period of five (5) years, and the applied finish for a period of three (3) years. These warranties are subject to the limitations outlined below (see section 2).

2. Limitations

a. The repair or replacement of parts, or the performance of service under this warranty, does not extend the life of this warranty beyond its original expiration date.

b. This warranty is non-transferable and is offered exclusively for the benefit of the original purchaser, beginning on the original date of retail sale.

c. Stoll Industries does not warrant this product against the following:

1. Damage occurring during transportation or installation, or damage resulting from improper installation.
2. Damage/breaking of the mounting tabs due to incorrect installation, or bending the tab multiple times.
3. Discoloration of finish or distortion of metal parts due to high heat.
4. Damage as a result of accident, alteration, abuse, or mis-use.
5. Scratches and damage from normal wear and tear.
6. Damages from not following the Care & Maintenance Instructions.

d. Color finishes may vary slightly in shade and are not guaranteed to perfectly match or coordinate. Color changes and variations may occur from direct exposure to sunlight and the elements. Extreme variation in finishes may be re-finished solely at Stoll Industries option and discretion.

e. This Warranty does not cover any costs of labor, installation, removal, subsequent damage or transportation, regardless of whether the work was performed by a contractor, service company, or the consumer.

3. Warranty Process

a. If, during the given warranty periods, a product covered under this warranty proves to be defective in material or workmanship, a claim for warranty service should be made through your authorized Stoll Industries Dealer. Proof of purchase will be required. The authorized dealer will contact Stoll Industries to procure replacement parts and/or if additional service is deemed necessary. **Stoll Industries, at its discretion, will choose the best method of repair or replacement for any warrantied part or product. This Warranty does not cover any costs of labor, installation, removal, subsequent damage, or transportation, regardless of whether the work was performed by a contractor, service company, or the consumer.**

CARE AND MAINTENANCE

OUTDOOR KITCHENS

To ensure a lifetime of use, and extend the longevity and beauty of your product, we recommend regular care and cleaning of your Stoll Outdoor Kitchen.

Routine cleaning can be accomplished by rinsing away dirt and debris, and then gently wiping with a damp, non-abrasive cloth or sponge using warm water. Towel drying will help prevent water spotting. If additional cleaning is necessary, mild household cleaners can be used. The use of solvents or abrasive cleaners may damage the product's finish, always test any cleaning solution in an inconspicuous area before applying to the entire product.

Storing objects on the surface for extended periods of time may trap moisture and debris, and dis-color or damage the finish.

Placing hot items directly on any surface of your outdoor kitchen may damage the finish. Hot ashes and exposure to ash debris over long periods of time may also cause damage. This type of damage is not covered under warranty.

Appliance and stainless steel cleaning solvents should never come in contact with your outdoor kitchen surface. Spray the solvent onto a cloth and wipe only on the appliance surface to help eliminate overspray.

Light or superficial scratches to the finish are likely to occur during normal use and do not affect the integrity of the product. Using your outdoor kitchen surfaces as a cutting board for food, or sliding items such as grilling tools, utensils, and abrasive or ceramic items across the surface may also cause wear and tear. This type of finish wear is considered normal, and is not covered under warranty.
